WHEN DID JOKOWI PLAN TO RIG THE ELECTION?

Controlling (1) election management bodies, (2) the Ministry of Home Affairs and (3) the Police (KPK)

KPU

EMB had been infiltrated by Jokowi's interests to win Prabowo & his son. The EMB selection process was chaired by someone from the Palace. Candidates with experience and integrity had been eliminated.



WHAT DID THE KPU DO THAT BENEFITED PRABOWO-GIBRAN?

1. KPU IS NOT INDEPENDENT

KPU followed the interests of the House. How is it possible for the KPU to comply with the DPR when they are the participants in the election? It's no wonder that all the regulations for the administration were delayed in being established because they had to negotiate with the parliamentary parties.

2. FRAUD IN THE VERIFICATION OF ELECTION PARTICIPANTS

Evidence has been found of the KPU's involvement in manipulating the verification process so that parties can pass as election participants. There are recordings, videos, and data showing KPU's involvement to the regional levels in this fraud.

3. LACKING INTEGRITY & LUXURY LIFESTYLE

The luxurious lifestyle of the KPU is evident from the use of private jets and the three cars owned by each KPU leader.

The integrity of KPU members is increasingly being questioned when the sexual violence case involving the KPU Chairperson receives support from both National and Regional KPU members, who stand behind the KPU Chairperson, who has been proven to have violated the organizer's code of ethics.



THE POLICE AS AN INSTRUMENT OF FRAUD

The replacement of regional and resort police chief positions is happening ahead of the presidential election. The names show the relationship with two people: President Joko Widodo and the Chief of the Indonesian National Police, Listyo Sigit. Sigit has been close to Jokowi since their time in Solo.

2. POLICE INVOLVEMENT

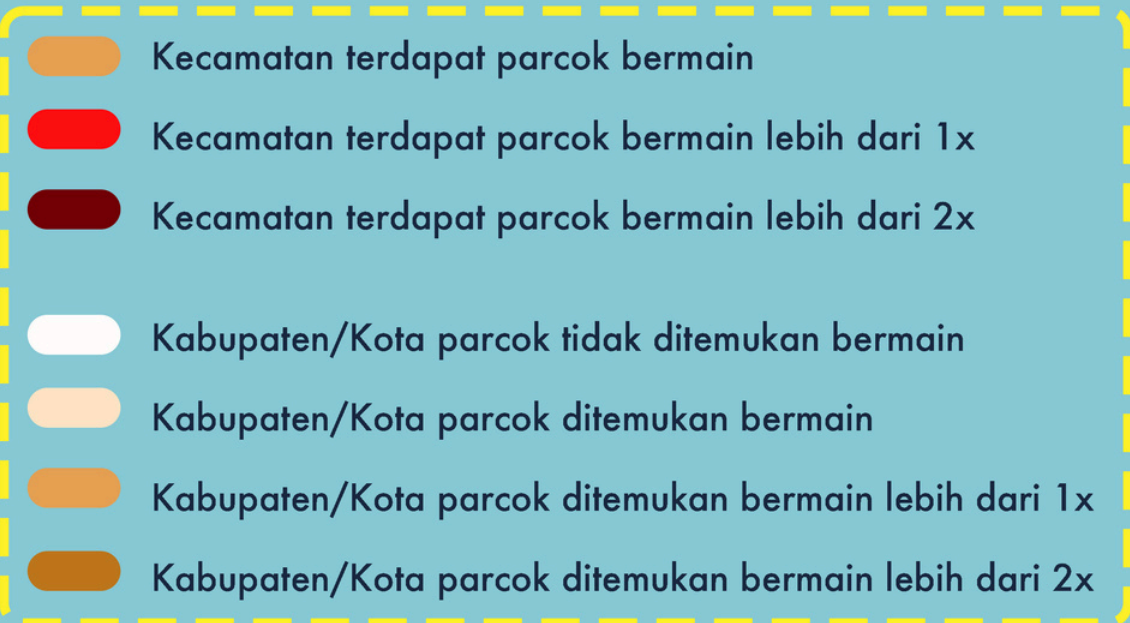
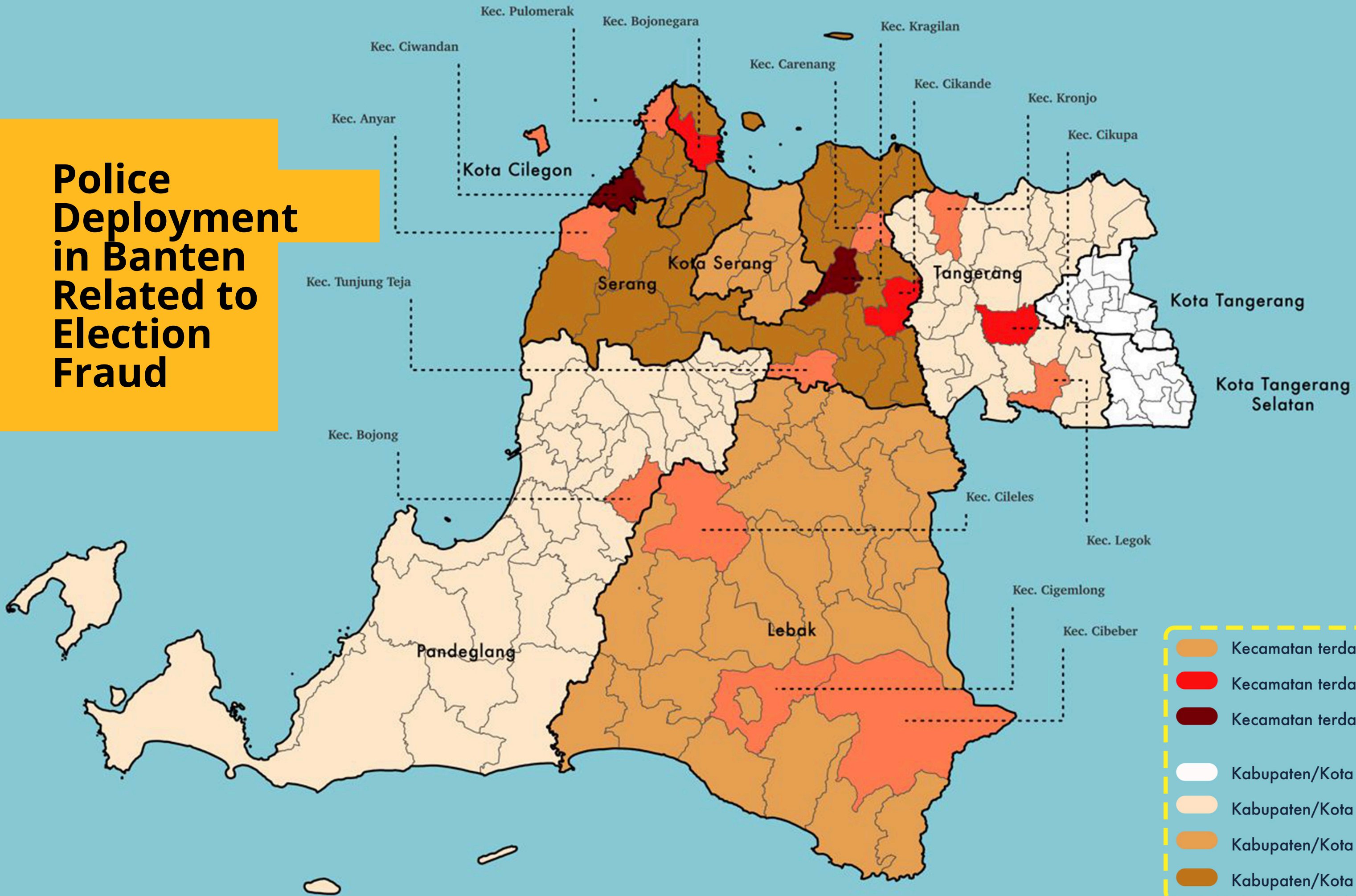
PORK BARREL & POLICE

The police also did the same throughout the Regional Head Election. They even used the term "cooling system" for distributing food supplies to the community, which is considered pork barrel politics. Moreover, the police summoned several village heads regarding village fund corruption unless they supported a certain candidate pair.

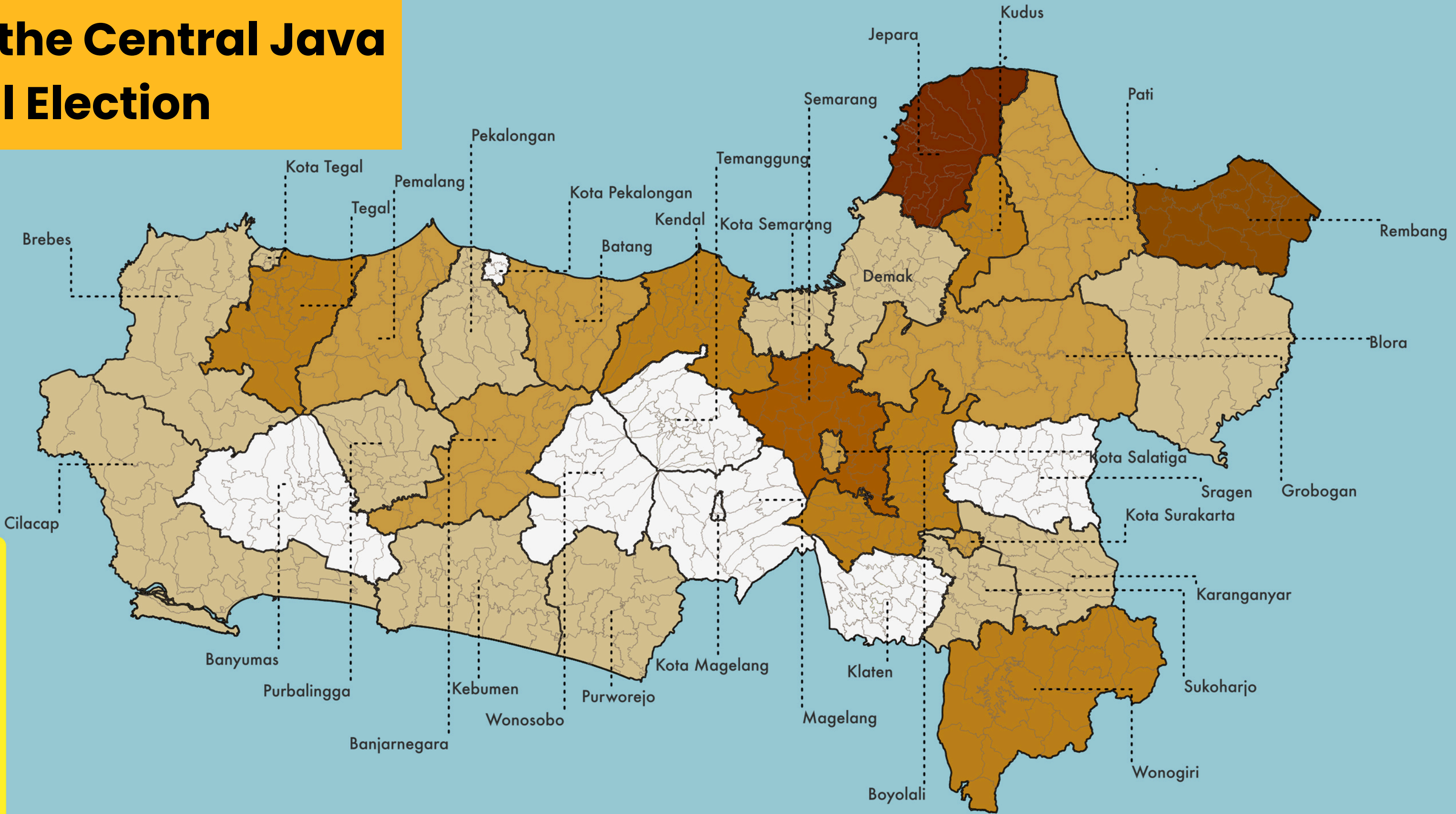
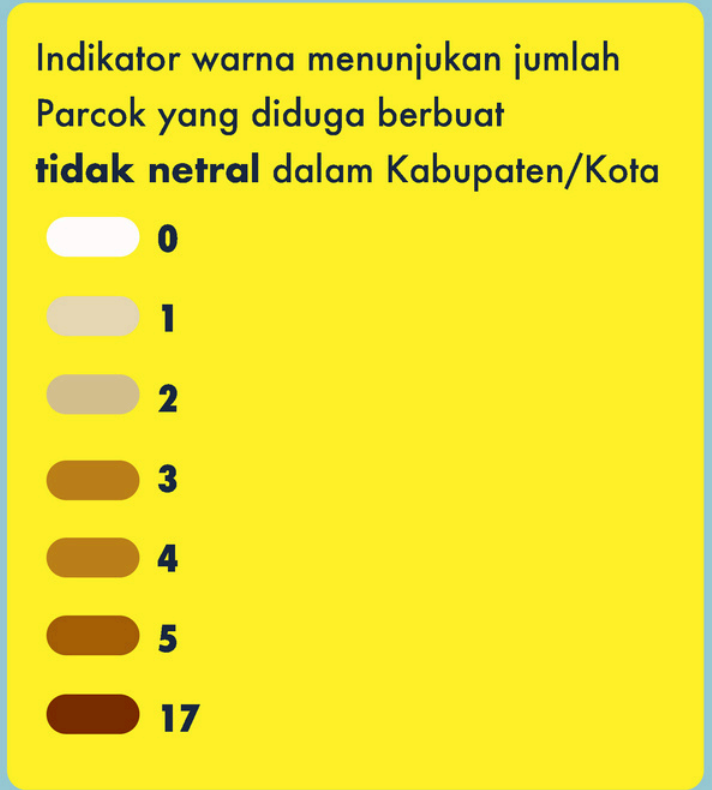
DEPLOYING THE POLICE

The Regional Police issued a different index of regional head election vulnerability (IKP) compared to the IKP version of the Election Supervisory Body. Based on that IKP, the police can deploy 27,000 personnel. (Kepolisian, Militer, dan pertahanan sipil). The placement locations are related to areas where there has been an increase in the number of votes for certain regional head candidates.

Distribution of Police Involvement in the Central Java Regional Election



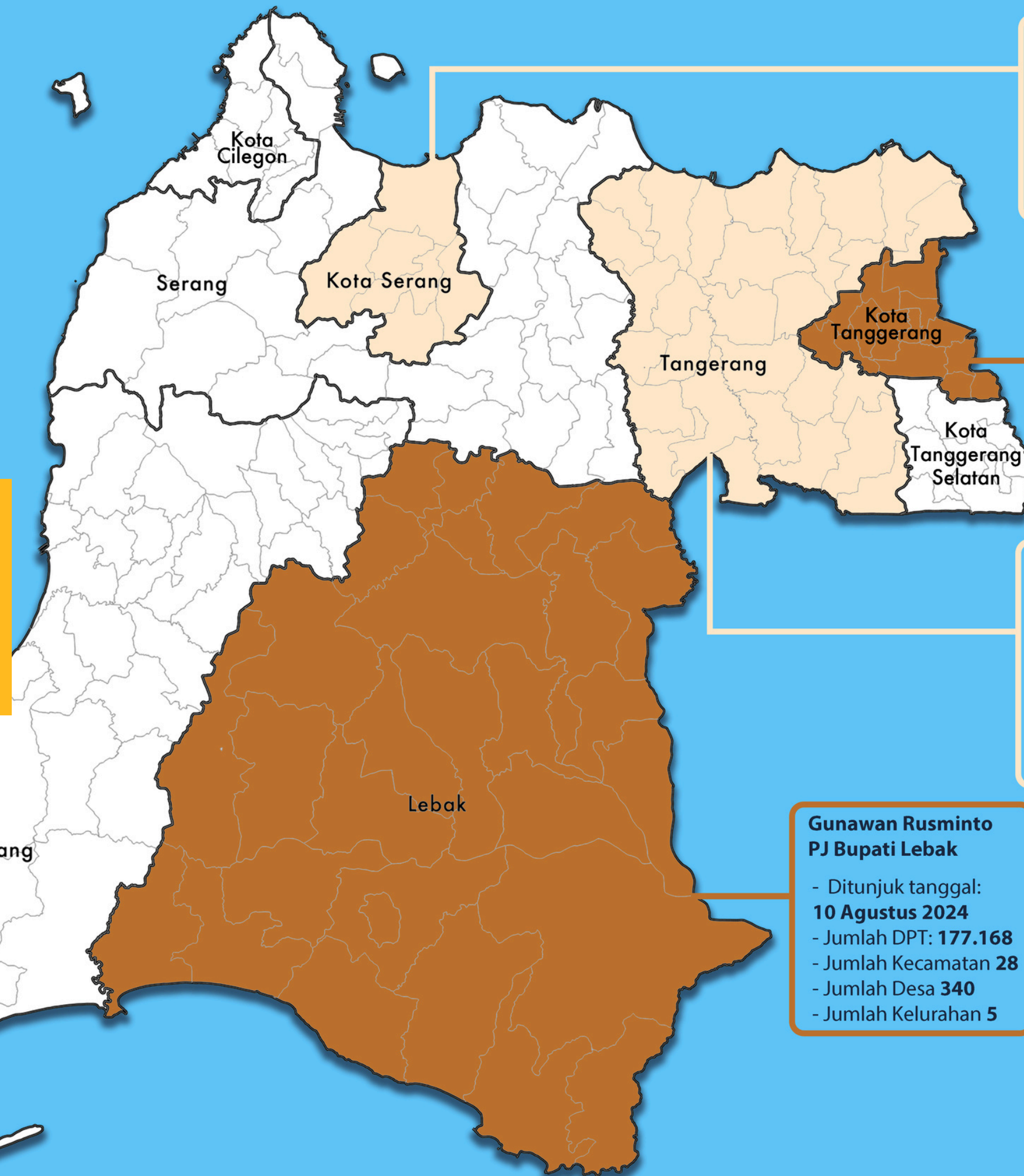

∴ Dealing with the village heads

The Village Head was promised an extension of the term of office from the original 5 years to 6 years and then 8 years per period.

The Village Head is a local government official who has direct access to the voters.

The number of Village Heads/Urban Village Heads is 84,276 regions. They are led by the Regional Head.

Joined the APDESI organization (Association of Village Heads) which declared support for Prabowo-Gibran.
