## Open data

---

### ❖ **Electoral register**(election law §41)

- Electoral register shall be open to the public for three(3) days through papers or internet website in order for voters to scrutinize it.
- Any person may file an objection orally or in writing when finding on omitted or misspelled entry or an ineligible voter on the list.

## Open data

---

### ❖ **Candidates info** (election law §49)

- Report on his/her own properties/debts
- Military service records
- Report on payment or default of income tax, property tax, and real-estate tax of the candidate, his/her spouse, his/her parents and children for the latest five(5) years
- Criminal records of fine( $\leq 1,000$ USD) or any heavier punishment
- Certificate of the highest education
- Report on the past candidate regist history

# Open data

---

## ❖ **Financial Reports** (Political Funds Act §§40,42)

- Report on financial accountant, bank account number
- Annual financial report (by Jan. 31)
- Election funds report (by 30 days after election)
  - Financial transaction records, documentary evidence, bank transaction history
- Public scrutinize for 3 months (internet website, papers)
- ECs' investigation authority (6 months)

# Open data

---

## ❖ Financial Reports (Political Funds Act §§40,42)

- Penalties
  - Delayed or false report
  - Disturbance against EC's lawful investigation
- If a financial accountant is sentenced to fine ( $\leq 3,000$ usd) or above, the relevant candidate elected is nullified
